Please read carefully before signing. This is a release of liability & waiver of legal rights.

I acknowledge and agree that I have decided to volunteer with Glen Ellyn Food Pantry, Inc. (GEFP) as a GEFP Volunteer, that I will receive no compensation or other employment-related rights or benefits from GEFP, that I am not an employee of GEFP and that my volunteer services for GEFP may be ended by me or GEFP at any time and for any reason. Now, therefore, in consideration of the covenants contained herein and other good and valuable consideration, I agree as follows:

ASSUMPTION OF RISK AND RELEASE OF LIABILITY AGREEMENT

Risks of Activity. I acknowledge and understand that there are risks associated with volunteering with any organization, including GEFP. I acknowledge and fully understand that the risks that I may face as a GEFP Volunteer include, but are not limited to: the risk of bodily injury to me caused by lifting; slip and fall; falling objects; conditions on the premises; failure of equipment and/or defects; and the acts and/or the negligence of others. Further, I acknowledge and understand that the description of the risks listed above is not complete and that participating as a GEFP Volunteer may include other risks.

Assumption of Risks. Accordingly, for good and valuable consideration, including but not limited to the privilege of volunteering with GEFP. I HEREBY AGREE THAT I VOLUNTARILY ASSUME ANY AND ALL RISKS (BOTH KNOWN AND UNKNOWN, INHERENT OR OTHERWISE) associated with my volunteer service for GEFP, including but not limited to those risks described above.

Release. I, on my own behalf and on behalf of my representatives, assigns and heirs hereby knowingly, irrevocably and voluntarily waive, unconditionally release, and forever discharge, and agree not to sue or bring any other legal action against GEFP (and its officers, directors, employees, agents, representatives, volunteers, and related parties) with respect to any and all responsibility, liability, claims, causes of action, demands, damages, costs, expenses (including attorneys' fees) or actions arising out of or relating in any way to my volunteer services with GEFP, including, but not limited to, all actions based upon negligence or other legal theory and all claims for any personal or physical injury or damage to me or my property, whether occurring on GEFP premises or otherwise arising in connection with my volunteer services at GEFP.

CONFIDENTIALITY AGREEMENT

As a volunteer of the Glen Ellyn Food Pantry (GEFP), I agree that during the time that I am a volunteer with GEFP and at all times thereafter, I will keep confidential and will not directly or indirectly use or disclose any and all personal, privileged and/or confidential information regarding GEFP that I obtain in the course of my involvement with GEFP, including but not limited to information regarding clients' identity and personal information and GEFP's organizational practices, projects, donors, potential donors, records, employees and volunteers.

MEDIA RELEASE

I understand that I may be photographed or videotaped (collectively "Media Materials") while volunteering for GEFP. I give GEFP and its funding partners permission to use Media Materials in which I am visibly recognizable in Annual Reports, newspaper articles, newsletters, on websites and in other promotional materials. I release GEFP (and its officers, directors, employees, agents, representatives, volunteers, funding partners and related parties) from any and all claims and demands arising out of, or in connection with, the use of Media Materials consistent with this agreement.
